



INSTRUCTIONS TO BIDDERS

(Single Stage Two Envelop E-Bidding System)

1. Technical proposal should accompany the following. The bidder should submit his technical proposal in light of bidding documents and evaluation criteria.
 - a- Enlistment of C&W Department Smart Card / PEC updated.
 - b- Documents showing general capabilities, financial soundness, general and relevant experience record personnel capabilities, equipment capabilities and Income Tax / NTN Certificate, etc.
 - c- Any other document to support the technical bid.
2. The contractors quoting their bids up to a limit of **10% below** Engineer estimate shall submit bid security @ **2%** only of Engineer Estimate.
3. The contractors quoting their bids more than **10% below upto 20% below** on Engineers Estimate shall submit along with their bids **8% Additional Security** of Engineer's Estimated cost in addition to **2% bid security**. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
4. Similarly, a contractor quoting bid more than **20% below** shall submit with his bid an additional security on Engineer's Estimated cost equal to the **differential amount** of submitted bid and Engineers' Estimate along with detailed rate analysis. In case of more than **20% below** bids, if the bid is not accompanied by the **detailed rate analysis** and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the **2nd** lowest bidder and so on will be considered accordingly.
5. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non responsive without any forfeiture of bid securities and record reasons thereof.
6. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
7. After commencements of work by the successful bidder, the procuring entity may replace the Additional Security with a bank guarantee of the same amount from the scheduled bank; if the already deposited security is not in the form of bank guarantee.
8. The Additional Security shall be released to the contractor in four installments i.e. **1st** installment of 25% to be released upon completion of 25% of the project, **2nd** installment of 25% to be released upon completion of 50% of the project, **3rd** installment of 25% to be released upon completion of 75% of the project and the **4th** installment of 25% to be released after 100% completion of the project.
9. All the bidding will be through E-Bidding system. Technical bid should be in sealed envelopes clearly mark "Technical Bid" Technical bid shall be submitted through courier half an hour before closing date and time.
10. All the bidders may be despoited tender form fee Rs. 0.03% on E/Cost by each participating contractor online along-with earnest money.
11. The bidders are required to quote their rates above or below on BOQ/MRS system on both MRS as well as no MRS items.
12. Technical evaluation will be carried out with pass / fail threshold. Passing criteria, includes PEC Registration Enlistment with C&W Deptt. Tax Payer proof, relevant experience in past 05-Years, performance. Technical Personnel, required Equipment, Financial status, Auditors report, Managerial capabilities, Litigation status etc mandatory.
13. Financial bid shall be filled online. Complete bid must reach the concerned offices on or before the fixed date / time. The CDR shall be enclosed in the Technical Proposal.
14. Any Electronic Bidder who provides incorrect information shall stand disqualified & de-barred.
15. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of LOA.
16. The Electronic Bids validity period is 90-Days.
17. Call deposit of Scheduled Banks shall be acceptable.
18. If the evaluated electronic bid costs of two or more than bidders are equal then the successful bid will be declared through draw.
19. Financial electronic Bids will be opened After receipt of approval of Technical Bid from Competent Authority.
20. Bid security of the **1st, 2nd and 3rd** lowest electronic bidder for the specific work will be retained by the Department till the approval of bids.
21. Undertaking on Judicial Stamp Paper i.e. 2% Security deposit attached with technical bid.
22. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority establishment under the Khyber Pakhtunkhwa Finance Act, 2013 other-wise he will not be entitled to participate in tendering process.
23. Any bidder applying for more then one work shall submit separate technical brousher clearly mentioning the name of scheme against which the technical bid is submitted.
24. Bidding documents along-with evaluation criteria can be obtained from the procuring entity on the submission of printing fee of **Rs. 5000/-** during working hours.
