- A copy of technical proposal in the required format is mandatory to be submitted in hard form in the office of the undersigned within due date and time and to be uploaded as a part of E-bid before submitting Financial Bid.
- All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013).
- The bidder should submit their E-bids as per KPPRA Notification No. S.R.O(14)/Vol: 1-24/2021-22 dated: 10-05-2022
- Original Copies of Call Deposit for Bid Security and Tender Fee should be enclosed in the Technical Proposal and shall reach to the Office before closing date/time
- 6. Legible Scanned copy of bid Security shall be submitted electronically along with the bid on E-bidding system.
- 7. All bidders are required that bid security shall be kept sealed in Financial Proposal. In addition keep an original affidavit in the technical proposal stating that a bid security in percentage of the estimated without indicating the figure.
- 8. Venue of bids opening is office of the Executive Engineer C&W Highway Division Swabi.
- Firm must be having PEC Renewal and C&W Renewal along with updated FBR status and valid audit report.
- 10. Firm with relevant experience, Staff and machinery capacity needed for project.

INSTRUCTIONS TO BIDDERS

(Single stage Two envelops E-bidding System)

- 1. Technical bid/ proposal should accompany the following:
 - a. Bid security in the shape of call deposit (original).
 - b. Enlistment Order of C&W Department (photocopy)
 - c. Renewal of registration for CFY 2024-25 (Photocopy)
 - d. National Identity Card (CNIC Photocopy)
 - e. Valid Pakistan Engineering Council registration copy for current calendar year.
 - f. Form-H of the Company / Firm.
 - g. Documents showing general capabilities, financial soundness, general and relevant experience record, personnel capabilities with proof, equipment capabilities registration with KPRA and Income Tax / NTN Certificates, etc.
 - h. Any other document to support the technical bid.
- 2. A copy of the technical proposals in the required format is mandatory to be uploaded as a part of E-bidding before submitting Financial Bids. Scanned copy of bid security shall be submitted electronically along with technical bid on E-bidding system.
- Non refundable bidding entry fee @0.03% of tender cost alongwith 02% E/Money and stamp duty in Shape of Call Deposit separately may be furnished (in original) to this office as recommended by the Sub-committee of the cabinet notified vide Section Officer (Confidential) Chief Minister's Secretariat Khyber Pakhtunkhwa Peshawar No. SO(C)/CMS/KPK/2020-21 dated: 21-04-2021.
- The Contractor quoting their bids up to a limit 10% below Engineer Estimate shall submit bid security @ 2% only of Engineer Estimate.
- 5. The contractor quoting their bids more than 10% below upto 20% below on Engineer's Estimate shall submit alongwith their bids 08% additional security of Engineer's Estimated Cost in addition to2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 02% bid security shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.
- 6. (Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer Estimated Cost equal to the deferential amount of submitted bid and Engineer's Estimate alongwith detail rate analysis). Incase of more than 20% below bids, if the bid is not accompanied by the detail rate analysis and / or required amount of additional security, than the said bid shall be considered as non responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.
- 7. In case detail rate analysis submitted with the bids is, in view of the procuring entity, non convincing, the head of the procuring entity may declared such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
- The Procuring Entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
- 9. Technical proposals should be in sealed envelope clearly marked "Technical Proposal" and in sealed envelope with signed BOQ clearly marked "Financial Bid". Technical proposals and financial bids shall reach the Bids opening venue before closing time.
- 10. Financial bid shall be filled online. Complete bids must reach the concerned offices on or before the fixed date/time.
- 11. Technical evaluation will be carried out with pass/fail threshold. Passing Criteria, include PEC Registration, Enlistment with C&W Department., Tax payer proof, Relevant Experience in past 05 years, performance, Technical Personnel, Required Equipment, Financial status, Auditor report, Managerial capabilities, Litigation status etc, as mentioned in application forms 1-9.
- 12. Any Electronic bidders who provide incorrect/incomplete information shall stand non responsive.
- Any Electronic bidders who submit fake or forged documents or information shall stand de-barred.
- 14. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of LOA.
- 15. Electronic bids validity period is 90-days.

- 16. Successful Bidder should sign the agreement with the department within Twenty Eight (28) days after issuance of LOA.
- 17. Call Deposit of Scheduled Banks shall be acceptable and must be stated in an original affidavit stating its authenticity.
- 18. If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bid will be declared through draw.
- 19. Technical Bids will be opened after 30 minutes of closing time in the presence of bidders/ their representatives who choose to be present.
- 20. Financial electronic bids will be opened after approval of Post-Qualification from the competent authority. After receipt of post-qualification approval, post-qualified bidders will be intimated by the undersigned for financial bids opening on due date & time.
- 21. The employer has the authority to reject any bid or all the bids assigning cogent reasons.
- 22. Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work will be retained by the Department till the approval of bids.
- 23. Firm must provided original affidavit for non Blacklisting
- 24. Firm must provide original affidavit for proving non involvement in litigation.
