- 3. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required of additional security, then the said bid will be dealt as per KPPRA Notification S.R. O (14) / Vol: I 24/2021-22 dated may 10-2022.
- 4. In case detailed rate analysis submitted with the bids is, in view of the procuring Entity not convincing, the head of procuring Entity may declare such bid as non-responsive.
- 5. Complete Detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically along with E-bid on the E-PADS System.
- 6. In cases of amongst the successful bidding, winner will be decided based on toss on the presence of all the bidders.
