Bidding Solicitation Documents along-with Bidding Criteria and instruction to bidders can be downloaded from the official EPADS website and C&W website ([www.cwd.gkp.pk](http://www.cwd.gkp.pk)) as well as KPPRA website ([www.kppra.go.pk](http://www.kppra.go.pk)) before the submission time. Bids submitted without requisite documents or incomplete will not be processed further for Technical Evaluation.
2. Bidders shall be required to submit an affidavit on stamp paper and place the same affidavit in the Technical Proposal, affirming that the CDR enclosed in the sealed financial bid is authentic and original. In case of non-availability of the affidavit, the firm/bidder shall be considered as non-responsive.
3. Original Copies of Call Deposit Receipts (CDRs) FOR Bid security (FROM Scheduled Banks), Stamp Duty is mandatory as well as Bid Entry Fee (Non-Refundable for each Bid @0.03% of the Estimated Cost without fail; to be enclosed along with the Technical Proposal and shall reach to the office before closing date / time.
4. A copy of the Technical Proposal as well as Financial Securities in the required format is mandatory and to be uploaded on EPADS System.
5. Electronic bidding will be done on "Above/Below" system on BOQ/ Engineer's Estimate, based on MRS applicable.

6. Electronic Bids will be displayed by online E-Bidding through EPADS system after 30-Minutes of closing time in presence of bidders/their representative.
7. Bid Security of 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> lowest bidder will be retained by the Procuring Entity till approval of the bid.
8. Any bidder who provides incorrect information shall stand disqualified and will be debarred.
9. The competent Authority reserves the right to reject any or all the tenders by assigning the cogent reason(s).
10. Bid will be valid for (90) days.
11. Details of similar nature and other general works, in hand and completed during last five years supported by work orders and completion certificates duly attested from Executing Agencies concerned.
12. Machinery (Tools, Plants & Equipment etc.) supported with the purchase documents as evidence of ownership.
13. Particular of Technical Staff/Engineers along with updated CVs and their agreement (for the current year) on stamp paper with the firm together with their qualification. Affidavit to the effect that the said personnel or their equivalent shall be made available for the job should also be given along with their registration number of PEC and contact numbers.
14. Financial soundness supported by annual Audit reports for the current year.
15. Tax returned certificate for the current year.
16. All other terms & conditions including KPPRA amended Rules can be seen on official website of the C&W Department or from the office of the undersigned on any working day during duty hours.
17. All Federal / Provincial duties / Stamp duties / Taxes will be recovered as per direction of the Government issued from time to time.
18. Separate Brochure / Technical Proposals for each work along-with required documents shall be submitted clearly mentioning the Scheme Name and No.
19. The Participating contractors(s) must submit their updated FBR (Active Status), KPRA (Active Status), PEC License and C&W Enlistment copies for the current financial year, for each work, on the day of opening of tender(s).
20. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) under Finance Act, 2013 Act No. XXI of 2013.
21. The Financial Bid will be opened after the approval of Technical Evaluation from the Competent Authority.
22. Period of Completion will be based on Work Order(s).
23. Any condition/Instructions, if missing will be dealt in light of KPPRA rules.
24. The undersigned has the right to reject the Bid of those Contractors whose past performance is not satisfactory with this Division shall be considered non-responsive.
25. Pre-Bid meeting will be held on 24-12-2025 (Wednesday) in the office of C&W Highway Division-II Peshawar at 11:00 AM.
26. Venue of bids opening is office of the Executive Engineer C&W Highway Division-II Peshawar at Plot No. 32, Phase- V, Adjacent to NADRA Office, Hayatabad Peshawar.

### **INSTRUCTION TO BIDDERS (ITB)**

Technical Proposal should be accompanied with the following:

1. Bidder shall submit an affidavit that Sealed Envelopes submitted along-with Technical proposal contains 2% Earnest Money.
2. The bidders should submit their E-bids as per KPPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22: Dated 10/05/2022.
3. Copies of valid registration with PEC, FBR and KPRA – Active Tax Payer
4. Copy of valid Enlistment Certificate of C&WD for the Current Year
5. National Identity Card (CNIC photocopy)
6. Form H in case of Company / Firm.
7. Detail of similar nature and other general works, in hands and completed during last five years supported by work orders and completion certificates duly attested from Executing Agencies concerned.
8. Machinery (Tools, Plants & Equipment etc.) supported with the purchase documents as evidence of ownership.
9. Particular of technical Staff/engineers along with updated CVs and their agreement (for the current year) on stamp paper with the firm together with their qualification. Affidavit to the effect that the said personnel or their equivalent shall be made available for the job should also be given along with their registration number of PEC and contact numbers.
10. Financial soundness supported by annual audit reports for the current year.
11. Tax Return Certificate for the current year.
12. Any other document to support the technical bid.
13. Evaluation of Technical Proposal will be carried out with pass/ fail threshold in passing all the field including PEC registration in relevant code, Enlistment with C&W in relevant code, Tax payer proof, relevant experience in past five years, performance, technical personnel, required equipment, financial status, auditors reports, managerial capabilities, litigation status etc. Evaluation criteria in this regard can be obtained from office of the undersigned on any working day in office hours or can be downloaded from the official website of C&WD.
14. All the bidding will be through E-PADS system. Technical Bid should in sealed envelope clearly marked: "Technical bid" addressed to the Executive Engineer C&W Highway Division-II Peshawar and shall be submitted through Pakistan Post/UMS/Courier before closing time.
15. The bidders are required to quote their rates (electronically) "ABOVE/BELOW/AT PAR" for both priced BOQ/Engineer Estimate based on MRS-2025 and NSI as well. Only two digits after the decimal point shall be considered for evaluation purpose.
16. The successful bidder shall be subjected to all admissible taxes including Stamp duty, service charges, sales tax and any other at prevailing rate.
17. Financial Bid shall be filled online. Complete bid must reach this office on or before the fix date and time.
18. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of work order.
19. Electronic Bid validity period is 90-days.
20. Successful Bidders should sign the Agreement with C&WD within (28) days after issuance of letter acceptance.
21. Call deposit and Bank guarantee of scheduled banks shall be acceptable.
22. If the evaluated electronic bid cost of two or more than two bidders are equal than the successful bid will be declared through open draw.
23. A Complete set of Criteria / Bid Documents should be obtained (separately for each Bid) by an interested eligible bidder on submission of written application from the office of undersigned on any working days before closing date on 29-12-2025 i.e. payment of Rs: 4000/- (non-refundable) otherwise his bid will not be entertained.

24. Those Bidders have not submitted the tender fee (previously) shall be considered an eligible and their bids will not be entertained.
25. The procuring entity has the authority to reject any bid or all the bids assigning cogent reasons.
26. Bid Security of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidders for the specific work will be retained by the authority till the approval of bids.
27. All the information and documents provided by the bidders must be based on fact beyond any doubt. Any miss representation, false statements or fact documents found in the proposal at any stage, would lead to the debarment/ black listing of the firm. The matter may also be reported to the PEC for cancellation of registration/ License of the respective firm.
28. Financial Electronic bids will be opened after approval of technical evaluation.
29. All bidders are required to be registered with the Khyber Pakthunkhwa Revenue Authority, established under Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in schedule-II of the Act ibid.
30. During the E-Bidding for Technical Proposal a separate form should be filled along with Financial Bid which is available on the C&W website.
