The Biddens registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) & Pakistan Engineering Council (PEC) in relevant category & field of specialization having adequate financial soundness, relevant experience personnel capabilities, required equipment and other requirements as included in ITB/ Bidding Documents can participate in the tender for the following Schemes:

- A pre-bid Joint Venture (JV) comprising bidders holding at least a C-2 or highest category of PEC will also be eligible to participate in the bidding process as per criteria set in SBD's.
- 3. Bidding documents including Priced BOQ/ Engineer Estimate, instruction to bidder (ITB), evaluation criteria etc. are available in the office of the undersigned and can be obtained on any working day during office hours at least three (03) days before the closing date on cash payment of Rs. 5000/- (Printing charges) and also are available on C&W website https://www.cwd.dkp.pk which can be downloaded for bidding purpose.
- The bidders are instructed to submit their bids through <u>E-PAD System</u> via https://kp.eprocure.gov.pk
- Both the Technical and Financial Bids must be submitted through the EPADS portal. In addition, hard copies of bids must also be submitted to the office of the Project Director Project Unit C&W Department Justice Talet Qayum Road Near Educator School North



- al Road Hasan Garhi Peshawar. Bidders failing to submit their bids through both systems shall be declared as non-responsive, and their bids shall not be considered for evaluation.
- All the bidding will be through E-PADS System. Technical bid should be in sealed envelopes
 clearly marked "Technical Bids" and shall be submitted through Pakistan Post/ UMS/ Courier
 before closing time.
- 7. The bidders are required to quote their rates (electronically) "ABOVE/ BELOW/ AT PAR" for both priced BOQ/ Engineer Estimate based on MRS-2024 (1st Bi- Annual) and NSI Items as well. Only two digits after decimal point shall be considered for evaluation purpose.
- All other items not mentioned in the BOQ but existing in the MRS-2024 (1st Bi-Annual) shall be paid at contractor's rate approved by the Competent Authority with approved area cost factor.
- Bids validity period is as per SBD's.
- 10. If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bid will be declared through Open Bowl Technique.
- 11. The Procuring Entity has the authority to reject any bid or all the bids assigning cogent reasons.
- 12. Bid security of the 1st, 2nd and 3nd lowest bidders for the specific work will be retained by the Authority till the approval of bids.
- 13 The bidders are requested to take into account, the Finance department notification No. SO(Dev-II)/FD/12-5/2014-15 dated 21-04-2015, if applicable; while quoting their rates.
- 14. All the information and documents provided by the bidders must be based on facts beyond any doubt. During analysis/ Scrutiny or evaluation of the proposals any misrepresentation, false statement or fake document would make a ground for rejection of the bid and will also be liable for debarment/ blacklisting. Any take document or misrepresentation detected during the currency of the contract, will render the firm to be black listed and would be reported to the PEC for cancellation of their registration/ license.
- 15. The pre-bid meeting is scheduled by the Procuring Entity on 13th November 2025 at 12:00 PM.

INSTRUCTION TO BIDDERS

- Technical proposal should accompany the following:
 - a. As the Procuring entity has fixed the amount of bid security on estimated cost, hence the bid Security shall be submitted along the technical proposal, otherwise, the technical proposal will be considered non-responsive and will be returned to the bidder after being examined by the procurement committee. However, in the case of additional required as per clauses 3 and 4 of this ITB, (stated below); such securities shall be made part of the sealed financial proposal.
 - A letter of intent addressed to Project Director, Project Unit C&W Department Peshawar.
 - c. The title page of brochures shall also contain the nomenclature of the work for which the bidder intends to apply.
 - d. Copy of valid Registration with PEC having codes as per SBD's.
 - e. Copy of valid Registration with KPRA.
 - Copy of valid Enlistment Certificate of C&WD.
 - National Identity Card (CNIC Photocopy)
 - h. Form H of the Company/ Firm.



The Contractors quoting their bids up to a limit of 10% below Engineer Estimate shall submit bid security @2% only of Engineer Estimate.

- The contractors quoting their bids more than 10% below up to 20% below on Engineer's Estimate shall submit along with their bids 8%, Additional Security in the shape of CDR/Bank guarantee of Engineer's Estimate cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
- 4. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineer's Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and if or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Government and the 2rd lowest bidder and so on will be considered accordingly.
- 5. In case detailed rate analysis submitted with the bids is, in view of the Project Director Project Unit C&W Department, not convincing, the Project Director may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof
- 6. Technical evaluation will be carried out in accordance with the evaluation criteria set in the SBDs which can be obtained from office of the undersigned on any working day in office hours or can be downloaded from the EPADS or official website of C&W Department.
