5. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority under the Khyber Pakhtunkhwa Finance Act, 2013 Act No.XXI of 2013.
6. The Financial bid will be opened after the approval of Technical bids from competent authority.
7. If a bid is more than 20% below the estimated rate, the bidder must submit a detailed rate analysis with the bid. If the procurement committee finds that analysis unconvincing, the head of the procurement entity can reject the bid as non-responsive.
8. Qualification documents can be obtained from the office of the undersigned during office hours for each work on payment of Rs.2500/- (Non-Refundable) upto 28-07-2026 05:00 PM.
