

The C&W Division Kohistan Upper, Government of Khyber Pakhtunkhwa invites electronic Bids from eligible firms / contractors in accordance with KPPRA procurement rules 2014, amended up-to 10/05/2022 on Single Stage single envelops procedure for the following work(s)

- Bid Solicitation Documents and Instructions to Bidders can be obtained from the office on any working day or downloaded from C&W website (www.cwd.gkp.pk) & KPPRA website (www.kppra.gov.pk) before the submission date / time.
- The bidders should submit their E-bids as per KPPRA Notification No. S.R.O (14)/Vol: 1-24/2021-22 dated 10/05/2022.
- Complete Detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically along with E-bid on the EPADS.
- The Procuring entity shall ensure that the bids of only those bidders be opened whose security deposit has been credited to their official account before opening of bid(s).
- In case, no security deposit is credited, the bid shall be considered non responsive and shall summarily be rejected.
- All bidders are required to be registered with Khyber Pakhtunkhwa revenue Authority under Finance Act, 2013 Act No. XXI of 2013.
- Venue of Bid opening is office of the Executive Engineer C&W Division Kohistan Upper.
- Tender Fees must be attached with Financial Bid, in shape of Call Deposit, if the same not found with the financial bid then his bid will be treated as Non responsive.
- The Bidders are required to quote rates above or below on both MRS as well as on non MRS items.
- The contractors quoting their bids up-to a limit of 10% below on Engineer Estimate shall submit bid security to the extent of 2% of Engineer Estimate.
- The contractors quoting their bids more than 10% below up to 20% below on Engineer's Estimate shall submit along-with their bids 8% an Additional Security on Engineer Estimate cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non responsive and 2% security shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be considered accordingly.

12. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineer's Estimate along with detail Rate analysis. In case of more than 20% below bid if the bid is not accompanied by the Detail Rate Analysis and /or required amount of additional security, than the said bid shall be considered as Non responsive. All the securities submitted along with such Non responsive bid shall be forfeited in favor of the Government and the 2nd lowest bidder so on will be considered accordingly.
13. In case Detail Rate Analysis submitted with the bids is, in view of the procuring entity, not convincing, the Head of the procuring entity may declare such bid as non responsive without any forfeiture of bid securities and record reasons thereof.
14. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement afresh.
15. After commencements of work by the successful bidder, the procuring entity may replace the Additional Security with a bank guarantee of the same amount from the scheduled bank, if the already deposited security is not in the form of bank guarantee.
16. The Additional Security shall be released to the contractor in four installments i.e. 25% to be released upon completion of 25% of the project. 50% to be released upon completion of 50% of the project. 75% to be released upon completion of 75% of the project and the remaining amount to be released after completion of the project.
17. All such effort to conspire to cartel making shall be considered as violation of Rule – 44 and shall be attributed towards miss-procurement under rule – 54 of procurement Rules ibid.
18. Electronic bids should be submitted electronically on or before the fixed date/time.
19. Financial bid shall be filled online. Complete bids must reach the concerned offices on or before the fixed date / time.
20. Any electronic Bidder who submits fake or forged documents or information shall stand De-Barred.
21. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of Letter of Acceptance (LOA).
22. Electronic Bids validity period is 90 days.
23. Successful Bidder should sign the agreement with the department within Twenty Eight (28) days after issuance of LOA.
24. Call Deposit of only scheduled Banks shall be accepted.
25. The evaluated electronic bid cost of two or more than two bidders is equal then the successful bidder will be declared through draw.
26. Electronic bids will be displayed by Online EPADS after 30 minutes of closing time in the presence of bidders/their representatives who chose to be present.
27. The employer has the authority to reject a bid or all the bid assigning cogent reasons.
28. Bid security of the 1st, 2nd and 3rd bidder for the specific work will be retained by the Department till the approval of the bid.
