- 2. As per KPPRA notification No. SRO.(14)Vol:1-24/2021-22 dated 10/05/2022 security shall be submitted by the bidders as under:
  - The Contractor quoting their bid more than 10% below on Engineer Estimate shall submit bid security to the extend of 2% of Engineer Estimate only.
  - II The Contractor quoting their bid more than 10% below upto 20% below on Engineer Estimate shall submit alongwith their bid 8% **Additional Security** of Engineer Estimate cost in addition to 2% bid security if the bid is not accompanied with required amount of additional security then it will be considered as non-responsive and the 2% bid security be forfeited in favour of government and the second lowest bidder and so on will be considered accordingly.
  - III Similarly a contractor quoting bid more than 20% below shall submit with this bid an additional security on Engineer Estimate cost equal to the different amount of submitted bid and Engineer Estimate alongwith detail rate analysis.   - IV In case detailed rate analysis submitted with the bids is in view of the procuring entity not convincing. The head of the procuring entity may declare such bid as non-responsive without any forfeited of bid securities of bid securities and record reason thereof.
  - V The procuring entity may offer the contract to next lowest bidders after due diligence in the context of financial difference below such two bids or may advertise procurement opportunity afresh.
