NOTICE INVITING TENDERING ON E-PADS
(SINGLE STAGE TWO ENVELOPE E-PADS SYSTEM)**

Communication & Works Department, **EXECUTIVE ENGINEER MEGA PROJECTS (SOUTH-II) D.I.KHAN** invites Electronic Bids from the eligible firms/Bidders Enlisted with C&W Department and Pakistan Engineering Council for the year 2025-26, in accordance with KPPRA Procurement Rules-2014 on Single Stage Two Envelope procedure, amended up-to vide Notification No. 5RO (14) Vol. 1-24/2021-22 Dated: 10-05-2022 and latest prevailing rules through EPADS for the following work.

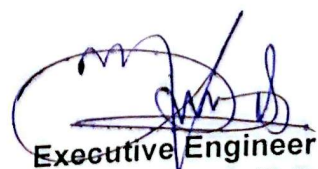

Terms & Conditions / Instructions to Bidders:

1. Bid Solicitation Documents and Instructions to Bidders, duly stamped and signed, shall be obtained from the office of the undersigned. The tender shall be processed through the KPPRA website using the E-PADS system. A mandatory Sale Proceed Fee of Rs. 5,000/- shall be charged for the Bid Solicitation Documents.
2. The contractors quoting their bids up to limit of the 10% below on Engineering Estimate shall submit bid security @2% only of Engineering Estimate.
3. The contractor quoting their bids more than 10% below up to 20% on Engineering Estimate shall submit along with their bids 8% Additional Security of Engineering Estimate cost in addition to 2% bid security, if the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of government and the second lowest bidder and so on will be considered accordingly.
4. Similarly, a contractor quoting their bid more than 20% below shall submit with his bid an additional security on Engineers Estimated cost equal to the differential amount of submitted bid and engineers estimate along with detailed rate analysis, in case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and/or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be considered accordingly.
5. In case detailed rate analysis submitted with the bid is, in view of procuring Entity, not convincing, the Head of procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reason thereof.
6. All the bidding process will be through E-PAD system. The contractor must submit Hard copy of detail /broachers of their firm for record purpose. However, their Evaluation /Marking will be given on E-PAD generated broachers in soft form.



- Technical Evaluation will be carried out on the basis of evaluation criteria detailed in the bidding documents. Failing to fulfill passing criteria, the bidder shall be considered as fail leading to disqualification of the bidder.
8. The Bidders are required to quote their rates (Electronically) ABOVE / BELOW / AT PAR on BOQ/Engineer Estimate/NSI in E-PAD system.
 9. The successful bidder shall pay all admissible taxes including stamp duty, service charges, sale tax and any other at prevailing rate.
 10. Call deposit of schedule banks / Bank Guarantee will be acceptable, issued in favor of Executive Engineer C&W Mega Projects (South-II) D.I Khan.
 11. No pay order and bank draft will be acceptable except call deposit of scheduled bank/ Bank guarantee, otherwise the bid will be declared as non-responsive.
 12. All bidders shall enter the details of the bid security and, where applicable, the additional bid security instruments in the E-PADS at the time of submission. The original bid security and additional bid security instruments, details of which have already been entered in EPADS, shall be submitted in the office of Executive Engineer (South-II) D.I Khan well before the closing date and time of bid submission.
 13. The original bid security and additional bid security instruments will be retained in the office of Executive Engineer Mega Projects (South-II) D.I Khan until signing of contract with the best evaluated bidder or till the bid validity period whichever is earlier.
 14. The bid securities in shape of call deposit (Original) shall be kept sealed in the financial proposal. The bidder shall in addition, place an affidavit (Mandatory) in the technical proposal clearly stating that the bid security amounting to 02% (percent) without indicating the figure in the letter, has been placed in the financial proposal/bid. Otherwise, the technical proposal will be considered as non-responsive.
 15. Technical bids will be opened in the office of Executive Engineer Mega Projects (South-II) D.I Khan on fixed date and time.
 16. Financial bid (Electronic Bids) of the technically qualified bidders will be opened in the office of Executive Engineer C&W Mega Projects (South-II) DI Khan after the approval technical bids of the qualified bidders.
 17. The Procuring entity has the authority to reject any bid or all the bids assigning cogent reason.
 18. All information and documents submitted by the bidders must be authentic and verifiable. Any misrepresentation, false statement, or submission of fake documents detected during scrutiny, evaluation, or during the execution of the contract shall result in rejection of the bid, debarment/blacklisting of the firm, and reporting to the Pakistan Engineering Council (PEC) for cancellation of registration/license, where applicable.
 19. Pre-bid meeting will be held on 10/09/2026 at 12:00 PM in the office of Executive Engineer Mega Projects (South-II) DI Khan and venue of Bids opening is Office of the Executive Engineer Mega Projects (South-II) D.I Khan.
