

TERMS & CONDITIONS:-

1. Bid documents can be downloaded from official website of C&W Department Khyber Pakhtunkhwa (www.cwd.gkp.pk).
2. Complete set of Bid Documents can be purchased from the O/O the undersigned on payment of non-refundable fee amounting to Rs.3000/- Per-Package on any working day one day prior to the opening.
3. All interested bidders shall deposit their CDR in the name of procuring entity (Executive Engineer Maintenance-II, Peshawar) prior to the closing date of bid submission in the Financial bid while an affidavit of its presence in the Technical bid.
3. Bidding shall be done on "Above/below" system on BOQ/Engineers Estimate based on the MRS applicable.
4. The bid shall be submitted online (E-PADS System) and 2% Security Deposit / CDR of the Engineer Estimated shall be sealed in Financial bid in shape of Call Deposit only (Original) before closing date and time. While the Technical bid should be uploaded online and submit in the office of undersigned
5. As per KPPRA Notification No.SRO(14)/Vol:1-24/2021-22/6058-71 dated 10th May, the bid shall be submitted online (E-PADS System) and 2% Security Deposit / CDR of the Engineer Estimated shall be sealed in Financial bid in shape of Call Deposit only (Original) before closing date and time. Regarding Bid Security & Additional Bid Security clear instructions have been given in the said Notification of KPPRA and the clauses shall be implemented on this bid.
6. Call Deposit of Schedule Banks shall be acceptable and no Bank Cheque or pay order shall be acceptable.
7. All other terms & Conditions of KPPRA and C&W Department with regard to procurement will remain intact.
8. QCR verified audit report from an A-rating firm for the last 3 years.
9. Firm must prove having an office / setup / sub office in Peshawar to be proved through documents.
10. Following codes are mandatory for the above mentioned schemes / works.
11. JV (Joint Venture) is allowed as per standard PEC and KPPRA rules and procedures.
12. Following affidavits are mandatory firms to be submitted in their Technical bid duly stamped and signed with date.
 - a. Affidavit for non-litigation against the department.
 - b. Affidavit for non-blacklisting / debarment of the firm.
 - c. Affidavit for the submission of earnest money i.e 2% of engineer estimate in the Technical Bid.
 - d. List of machinery / equipment which are related.
13. Firm must prove the human resource / staff both skilled and unskilled, in their Technical Bid.
14. Firms must prove their relevant experience of Maintenance work therefore work orders along with satisfactory / completion certificates issued by the executing agency.
15. Firm must show their ongoing / current commitment of relevant works in hand / progress.
16. Bank Statement must be for the last 3 Financial years showing ample for the works applied in working balance.
17. Credit line must be shown by the firm showing ample available line against the work applied.
18. Firm must have renewed / valid C&W/PEC/KPPRA/FBR registration and active statement.
