**NOTICE INVITING E-PADS**

(Single Stage Single Envelop E-Pak Acquisition and Disposal System (E-PADS))

The C&W Building Division Charsadda Govt: of Khyber Pakhtunkhwa invites tender through E-PADS system from the eligible firms / Contractor in accordance with KPPRA procurement rules 2014 amended upto 10-05-2022 on single stage single envelop procedure for the following work.

1. Instruction to bidders can be downloaded up to one day prior to the opening date from EPADS web site (<https://kp.eprocure.gov.pk>).
2. As per Clause 37 (A) of KPPRA Rules, all bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority.
3. Complete Detail of Bid Security in shape of CDR i.e Bank Name, CDR Number (s) and Date (s) must be submitted electronically along with E-bid on the E-Pak Acquisition & Disposal System (EPADS).
4. As per KPPRA notification No. S.R.O (14)/Vol-1-24/2021-22 dated 10/05/2022 the additional Security shall be submitted by the bidders as under:
  - i. The Contractors quoting their bids upto a limit of 10% below Engineer Estimate shall submit bid security @2% only of Engineer Estimate.
  - ii. The contractor quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
  - iii. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineer's estimated along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.
  - iv. In case detailed rate analysis submitted with the bids is, in view of the procuring entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
  - v. The procuring entity may offer contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
5. As per instruction of Chief Engineer (Centre) C&W Department Peshawar that requisite amount of bid security of the participating bidders shall be paid into treasury before submission of tender documents.
6. Bid Security of 1<sup>st</sup> 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidder will be retained by the procuring entity till approval of the bid.
7. Bid shall accompanied with 0.03% of E/Cost as tender entry fee in shape of separate CDR which is non refundable.
