- Bid Solicitation Documents and instructions to Bidders can be downloaded from the E-PAD website and attest from the undersigned or can be obtained from the office of the undersigned on any working day on paying printing cost of the document before the submission date/time.
  - Registration Certificate with P.E.C in C6 Category duly renewed for the current year.
  - Proof of registration with Khyber Pakhtunkhwa Revenue Authority (Active Tax Payer List) under Finance Act, 2013 Act No. XXI of 2013.
  - Valid Enlistment registration card from C&W department Peshawar KPK and Photocopy of CNIC.
  - In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and required additional security, then the bid will be considered as non-responsive as per KPPRA Notification S.R.O (14)/Vol:1-24/2021-22 dated May 10,2022. In case detailed rate analysis submitted with the bids is, in view of the procuring Entity not convincing, the head of the procuring Entity may declare such bid as non-responsive
  - Complete detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically on E-PAD system while hard copy must be submitted to the undersigned before the closing date/time. Failure to submit hard copy of original CDR will lead to debarment of the contractor concerned for one year as per KPPRA notification No. S.R.O. (29)/Vol:1-40/2025-26 dated 29-10-2025. Photocopy of CDR's is not acceptable.
  - In cases of tie amongst the successful bidders, winner will be decided based on toss in the presence of all the bidders.
  - Bid not fulfilling any of the criteria as stated above and in the bidding documents will be declared non-responsive.*
  - All Federal /Provincial duties/ Stamp duties/ Taxes will be recovered as per directions of the Government issued from time to time.
  - The Tender Entry fee @Rs. 0.03% of the total tender cost shall be submitted in separate envelope in the shape of original CDR before opening of tender. Failing which the bidder shall be considered as non-responsive.
