**NOTICE INVITING E-BIDDING**

**(Single Stage 2-Envelop Procedure E-Bidding System)**

Executive Engineer C&W Building Division, District Charsadda Government of Khyber Pakhtunkhwa invites electronic Bids from the eligible firms/bidders Registered With Pakistan Engineering Council in Relevant Code and Specialty in accordance with KPPRA procurement rules 2014, and also enlisted with C&W Department, on single stage 2- envelopes procedure for the following work:

The Financial Bid opening date will be intimated to all concerned after finalization of Technical Evaluation by the Procurment Committee.							

1. Instruction to bidders can be downloaded up to one day prior to the opening date from C&W web site ([www.cwd.gkp.pk](http://www.cwd.gkp.pk)).
2. As per Clause 37 (A) of KPPRA Rules, all bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority.
3. As per KPPRA notification No. S.R.O (14)/Vol-1-242021-22 dated 10/05/2022 the additional Security shall be submitted by the bidders as under:
  - i- The Contractors quoting their bids upto a limit of 10% below Engineer Estimate shall submit bid security @2% only of Engineer Estimate.
  - ii- The contractor quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
  - iii- Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineer's Estimated along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
  - iv- In case detailed rate analysis submitted with the bids is, in view of the procuring entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
  - v- The procuring entity may offer contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
4. Bid shall accompanied with 0.03% of E/Cost as tender entry fee in shape of separate CDR which is non refundable.
5. Complete set of Bid solicitation documents/Criteria can also be obtained on submission of a written application alongwith Photo copies of KPRA, PEC, Enlistment renewal for the Year 2024-25, upto 06/03/2025 from the office of the undersigned on cash payment non refundable amounting to Rs.2000/ , otherwise bids submitted without these documents will not be processed for post qualification.
6. All bidders shall submit an affidavit in the Technical bid, stating that bid security + Additional Security has been placed in the Financial bid without indicating figure, Otherwise the Technical proposal will be considered as non responsive.
