- 17- Bid Solicitation documents and instructions to bidder can be obtained from the office of the undersigned on any working day or downloaded from C&W website www.cwd.gkp.pk & KPPRA website www.kppra.gov.pk before the submission date/time.
- 18- The Bidders should submit their E-Bids as per KPPRA Notification No. SRO (14)/Vo: 1-24/2021-22, dated: 10.05.2022.
- 19- Complete data of bid security in shape of CDR i.e. Bank name, CDR number (s) must be submitted electronically along with E-bid on the EPADS-Bidding system.
- 20- All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority under Finance Act, 2013 Act No. XXI of 2013.
- 21- Venue of bids opening is Office of the Executive Engineer Upper C&W Division Kurram.
- 22- Tender Fees must be attached with Financial Bid, in shape of Call Deposit, if the same not found with the financial bid than his bid will be treated as Non-Responsive.
- 23- The Bidders are required to quotes rates above or below on both MRS as well as on non MRS items.
- 24- The Bidders should submit their E-Bids as per KPPRA Notification No. SRO (14)/Vo: 1-24/2021-22/7058-71, dated: 10.05.2022.
- 25- Electronic bidding shall be done on "above/below system" on BOQ/Engineer's Estimate. Only two digits after the decimal point shall be considered for evaluation purpose.
- 26- Bidding documents can be downloaded from the official EPADS website (i.e. eprocure.gov.pk) after publishing the NIT. The SBD must be filled neatly, and clear scanned copy of the same must be uploaded at the time of application (bid Submission) through EPADS.
- 27- Cutting/overwriting/manipulation in the bid solicitation documents will not be acceptable. Any mismatch between the scanned copies submitted through EPADS and those submitted in hard form will lead to disqualification and contractor will be considered non responsive.
- 28- Bid Security of 1st, 2nd and 3rd lowest bidder will be retained by the procuring entity till approval of the bid by the competent authority.
- 29- Any bidder who provided incorrect information shall stand disqualified as per KPPRA Act Section 29(I) rule (43).
- 30- The procuring entity has the authority to reject any bid or all bids assigning valid reasons.
- 31- All the prevailing KPPRA rules /Act and other Govt. notifications will be applicable issued from time to time.
- 32- All documents received to the office of the undersigned unsealed will be rejected.
