Communication and works Department (C&W Division, Hangu) Government of Khyber Pakhtunkhwa invites electronic Bids from eligible firms / Contractors (Register with PEC in relevant category and KPRA) in accordance with KPPRA Procurement rules 2014 on single stage two envelope procedure for the following works:

1. Instruction to bidder and bidding documents of the project are available at EPAD system, KPPRA and can also be obtained from the office of Executive Engineer C&W Division Hangu.
2. The Contractors quoting their bids up to a limit of 10% below on Engineer Estimate shall submit bid security @2% only of Engineer Estimate.
3. The Contractors quoting their bids more than 10% below upto 20% below on Engineer Estimate shall submit alongwith their bids 8% Additional Security of Engineer Estimate cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government.
4. A Contractor quoting bid more than 20% below shall submit with his bid as additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineer's Estimate alongwith detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive.
5. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
6. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
7. As per circular issued by KPPRA vide no. SRO(35)/Vol-1-46/2025-56 dated 27<sup>th</sup> August 2025, online submission of Technical and Financial proposal are mandatory for the bidder. If the bidder is unable to upload the proposals because of any reason, same can be submitted to the Office of Executive Engineer, C&W Division Hangu through courier or by hand before closing date and time of submission.
8. Mandatory submission of documents in hard form in the office of Executive Engineer C&W Division Hangu by the bidders are: (as to be uploaded by procuring entity on EPAD System).
  - a) Bidding entry fee (0.03 of the estimated cost) in shape of CDR (Non-refundable).
  - b) Bid security fee (2% of the estimated cost) in shape of CDR.
  - c) Certificate / affidavit by the bidder stating that additional security, if applicable as per KPPRA rules, has been submitted alongwith financial proposal in shape of CDR.
9. Bid security of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidders will be retained by the procuring entity till approval of the bid.
10. The firm / Contractor who does not have the code of C4/ME03 in Pakistan Engineering Council (PEC) for the work at Sr. No 2, will be disqualified.
