- The Contract will be awarded to the bidder under Section 28(e) of the KPPRA Act,2012 whose bid is responsive and is determined as the best evaluated bid as defined in Section2(1)(c)(ii) of the Act ibid.
- 4. All Bidders are required to be Registered with the Khyber Pakhtunkhwa, Revenue Authority, Established under the Khyber Pakhtunkhwa, finance act, 2013 (Khyber Pakhtunkhwa, Act No. Xxi of 2013), for works, Consulting and Non-Consulting Services as listed in schedule-ii of the act ibid, with Pakistan Engineering Council (PEC) and KPRPA
- E. All the bidders will have to submit CDR on account of E/Money & Additional Security what so ever and from Scheduled Bank on Account of bidding entry fee (Not Refundable) for each bid@0.03% of the Estimated Cost in hand along with technical bids without fail, otherwise his bid will not be entertained.
- The contractors quoting their bids more than 10% below and up to 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
- 7. [Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's Estimated Cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis]***. In case of more than 20% below bids, if the bid is not accompanied by acceptable/authentic the detailed rate analysis and /or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be considered accordingly.
- E. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as nonresponsive without any forfeiture of bid securities and record reasons thereof

SINGLE STAGE SINGLE ENVELOPS E-BIDDING SYSTEM INSTRUCTION TO BIDDERS.

- 1. Bid Security 2% of the Estimated Cost in the shape of call deposit in (original) in the name of Executive Engineer Building Division-I Peshawar shall be sealed in separate envelope clearly marked as "Bid Security".
- 2. (i). The contractors quoting their bids up to a limit of 15% below Engineer Estimate shall submit bid Security to the extent of 2% of Engineer Estimate only.
 - (ii). The contractors quoting their bids more than 15% below on Engineer's Estimate shall submit along with their bids an Additional Security to the extent of their bid/rates more than 15% below on engineer estimate in the form of percentage.
 - (iii). In case the bidder quotes more than 15% below the Engineer Estimate and the bid is not Accompanied by the Additional Security then the bid shall be considered as non-responsive and the 2nd lowest bidder and so on will be considered accordingly.
 - (iv). In case a contractor quotes more than 30% below on Engineer Estimate, the procuring entity shall in addition to additional security. Require the contractor to produce detailed rate analysis of his bid price in relation to any or all the items of bill of quantities, scope of work, allocation of risks and responsibilities and/or any other requirement of the bid solicitation document. The contract shall be awarded to the lowest evaluated bidder who has satisfied the procuring entity on rate analysis. However, if the procuring entity determines that the contractor has failed to demonstrate its capability to execute the contract at the offered price the matter shall be referred to the next higher authority for rejection of the bid on the basis of being financially unviable.
 - (v). The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
- 3. Electronic Bids should be submitted electronically on or before the fixed date/time.
- 4. Electronic Bidding shall be done on "Above/below" system on BOQ/Engineer's estimate, based on the MRS application. Only two digits after the decimal point shall be considered for evaluation purpose.
 - 5. Any Bidder who provides incorrect information shall stand disqualified and will be debarred.
 - 6. Time allowed for completion of the work is as specified in the NIT which will start from the issuance of L.O.A.
 - 7. Electronic Bids will valid for Ninety (90) days.
 - 8. Successful Bidder should sign the agreement with the department within Twenty Eight (28) days after acceptance of bid.
 - 9. Call Deposit of scheduled Banks shall be acceptable from the respective Bank Account of the Contractor/Firm.
 - 10. If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bidder will be declared through draw.
 - 11. Electronic Bids will be displayed by Online E-Bidding System after 30 minutes of closing time in the presence of bidders/ their representatives who chose to be present.
 - 12 The employer has the authority to reject any E-bid or all the E-bids assigning valid reason.
 - 13 The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids and the market analysis in order to discourage cartel making and to protect public interest at large.
 - 14. Pay Order is hereby non-acceptable bid vide KPPRA Notification No.KPPRA/M&E/Estt:/1-12/2017-18 dated 05-04-2018.
 - 15 The Sub Clause-16.5 of Clause IB. 16 of Instruction to Bidders of the Standard Bidding Documents for Procurement of Small Works a Bid determined as substantially non-responsive will be rejected and will not subsequently be made responsive by the bidder by correction of the non-conformity.
 - All the bidders will have to submit CDR from Scheduled Bank on Account of bidding entry fee (Not Refundable) for each bid@0.03% of the estimated cost without fail, otherwise his bid will not be entertained.
 - 17. All the interested eligible bidders shall deposit their Call Deposit Receipt (CDR) in the name of Procuring Entity five days prior to the closing date of bid submission.
 - The Procuring Entity shall ensure that the bids of only those bidders be opened whose security deposit has been credited to their official account before opening of bids.
 - 19 In case, no security deposit is credited, the bid shall be considered non-responsive and shall summarily be rejected.
 - 20 Bid security of the 1st, 2nd and 3rd lowest Electronic Bidder for the specific work will be retained by the Department till the approval of bids.
 - 21 The Procuring Entity will be declare those firms non-responsive those do not fulfill the terms and conditions of the Procuring Entity set forth in the tender notice and bid solicitation documents.
