- Bidding Solicitation Documents along-with Bidding Criteria& instruction to bidders can be downloaded from the official / EPADS website and C&W website ([www.cwd.gkp.pk](http://www.cwd.gkp.pk)) as well as KPPRA website ([www.kppra.gov.pk](http://www.kppra.gov.pk)) before the submission time. Bids submitted without requisite documents or incomplete will not be processed further for technical evaluation.
- Bidders shall be required to submit an affidavit on stamp paper and place the same affidavit in the technical proposal, affirming that the CDR enclosed in the sealed financial bid is authentic and original. In case of non-availability of the affidavit, the firm/ bidder shall be considered as non-responsive.
- The Contractors quoted their bids up to a limit of 10% below on Engineer Estimate shall submit bid security @2% of Engineer Estimate.
- The contractors quoting their bids more than 10% below up to 20% below on Engineer's Estimate shall submit along with their bids 8% Additional Security of Engineer Estimated cost in addition to 2% security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
- Similarly, a contractor quoted bid more than 20% below shall submit with his bid an additional security on engineer's estimated cost equal to be differential amount of submitted bid and engineer's estimate along with **detail rate analysis**". In case of more than 20% below bids. If the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Govt: and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
- In case detailed rate analysis submitted with the bids is, in view of the procuring entity, not convencing the Head of Procuring entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
- Original copies of call deposit receipts (CDRs) for bid security (from schedule Banks). Stamp duty is mandatory as well as Bid entry fee(Non-Refundable for each Bid @0.03% of the estimated cost, to be enclosed along with the Technical Proposal and shall reach to the office before closing date/ time.
- A copy of the Technical Proposal as well as Financial Securities in the required format is mandatory and to be uploaded on EPADS system.
- Electronic bidding will be done on "Above/ below" system on BOQ/Engineer's estimate, based on MRS applicable, as well as the attested copy of BOQ's / financial bid must be submitted to this office.
- Bid security of 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> lowest bidder will be retained by the Procuring Entity till approval of the bid.
- Any bidder who provides incorrect information shall stand disqualified and will be debarred.
- The competent Authority reserves the right to reject any or all the tenders by assigning the cogent reasons.
- Details of similar nature and other general works, in hand and completed during last five years supported by work orders and completion certificates duly attested from Executing Agencies concerned.
- All federal / Provincial duties/ Stamp duties/ Taxes will be recovered as per direction of the Govt: issued from time to time.
- Separate Brochure / Technical Proposal for each work along-with required documents shall be submitted clearly mentioning the scheme Name & No.
- All bidders are required to be registered with Khyber Pakhtukhwa Revenue Authority (KPPRA) under Finance Act, 2013 Act No.XXI of 2013.
- The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
- The undersigned has the right to reject the Bid of those Contractors whose past performance is not satisfactory with this Division shall be considered as non-responsive.
- Financial bid will be opened after the approval of Technical Bids from competent authority.
